Subject: Selection Committee Results: State ESG CV 2 Request for Applications

On February 3, 2021, the Homeless Trust made available a Request for Applications for the State Emergency Solutions Grant (ESG) Corona Virus (CV) 2 competition. This RFA process was used to select respondents that will be included in our collaborative application to the State Office on Homelessness pursuant to their ESG CV 2 solicitation. Notice of the RFA was properly advertised in English, Spanish and Creole newspapers of local circulation. A Pre-Application workshop was held on February 8, 2021, and respective addenda issued in response to questions submitted. The due date and time for submission of responses to this RFA was 2:00 p.m. on Monday, March 1, 2021. All applications were received via email.

A total of two (2) funding categories, Street Outreach and Rapid Re-housing were solicited for new projects benefiting the homeless. Street Outreach responses could include Emergency Shelter costs in their request for funding. The Selection Committee received nine (9) applications from seven (7) respondents. The committee met on March 8, 2021 to review, score, and recommended funding to two (2) projects under the Street Outreach funding category, and three (3) projects under the Rapid Re-Housing category. The Selection Committee's recommendations are subject to the state awarding funds to Miami-Dade County, as such, the committee gives staff the flexibility to negotiate price and number of persons served with the selected respondents.

Attached herein is the committee's summary scoring, ranking and funding recommendations.

These recommendations will be considered by the Miami-Dade County Homeless Executive Committee members on Friday, March 12, 2021 at 9:30 a.m.

We appreciate the Selection Committee's participation and diligence throughout this process.
